Associate Clinical Social Workers – Associate Marriage Family Therapists Bilingual Korean, Cantonese, Mandarin, Spanish, Tagalog, Vietnamese

APCTC is a private, non-profit, community based mental health clinic with over 35 years of service to the Asian Pacific Islander community in Los Angeles County. Asian Pacific Counseling & Treatment Centers is a division of Special Service for Groups (SSG) and was the very first mental health center in LA County specifically developed to meet the unique needs of rapidly growing numbers of API immigrants and refugees who needed a wide range of mental health services. With five locations throughout LA County and a satellite location in Riverside County, APCTC provides mental health services to individuals of all ages with diverse ethnic, gender, and racial backgrounds, struggling with mental illness and behavioral health challenges. While our centers specialize in serving the monolingual Asian Pacific community, we provide services to the entire community and offer services in English and Spanish as well.

APCTC has full-time therapist positions at our **Main, Wilshire, Alhambra, and Cerritos locations**. **Depending on program assignment, the candidate will be working either adult/older adults or with children and family programs.** The therapist will be working with diverse age, racial, ethnic, gender groups who have moderate to persistent mental illness. Bilingual in Chinese, Korean, Spanish or one of the Asian Pacific Islander languages is highly desirable.

Responsibilities: Under the supervision of the Program Manager and Clinical Supervisor, the ACSW/AMFT has primary clinical responsibilities in providing individual, group and family counseling, intake assessment, crisis intervention, case management and outreach services at our clinic, school-sites, client's home, and community locations accessible to clients. Depending on program assignment, the ACSW/AMFT will spend a portion of their time providing mental health services in a program specifically for either children/transitional age youth, APIDA LGBTQIA2S+ populations or with adult/older adult populations. The ACSW/AMFT will collaborate with inter-agency staff to serve our clients, including staff from schools, health care, DCFS, DPSS/GAIN, Probation Department, Regional Center, board and care facilities, etc. The ACSW/AMFT must have effective time management and communication skills, and capable of working in a diverse, inter-disciplinary team of psychiatrists, therapists, case managers, substance abuse counselor, parent partner, etc.

Requirements: Candidate must have a valid registration with BBS, a valid California driver's license and reliable transportation, knowledge/training in the DSM-V and able to adapt to a fast-paced work environment. We are looking for candidates who have a passion to help under-served API ethnic populations and interested in gaining experience in community mental health. The candidate must **have experience working with LGBTQIA2S+ communities if applying for the children's program**. Knowledge of LAC-DMH paperwork is highly preferred.
