APCTC is a private, non-profit, community based mental health clinic with over 40 years of service to the Asian Pacific Islander community in Los Angeles County. Asian Pacific Counseling & Treatment Centers is a division of Special Service for Groups (SSG) and was the very first mental health center in LA County specifically developed to meet the unique needs of rapidly growing numbers of API immigrants and refugees who were in need of a wide range of mental health services. With six locations throughout LA County and a satellite location in Riverside County, APCTC provides mental health services to individuals of all ages with diverse ethnic, gender and racial backgrounds, struggling with mental illness and behavioral health challenges. While our centers specialize in serving the monolingual Asian Pacific community, we provide services to the entire community and offer services in English and Spanish as well.

APCTC has a full-time therapist positions at our **Alhambra location (1635 W. Main St. #100, Alhambra, CA 91801)**. The candidate must be **fluent in Cantonese, Mandarin**. We are seeking candidates who want community mental health experience and have an interest working with diverse age and racial groups, LGBTQIA2S+ and under-served API ethnic communities with moderate to persistent mental illness.

Responsibilities: Under the guidance of the Program Manager and Clinical Supervisor, the PSW I/AMFT has primary clinical responsibilities in providing individual, group and family counseling, intake assessment, crisis intervention, outreach and referral services at our clinic, school-sites, board and care facility, client's home or facilities where clients reside. Depending on program assignment, there will be close collaboration with relevant parties, such as school staffs, GAIN workers, DPSS workers, DCFS workers, Probation officers, Regional Center workers, family members, board and care facility, etc. The candidate must be reliable to independently manage himself or herself in the field and communicate efficiently with the treatment team, supervisors and managers.

Requirements: Candidate must have Master's Degree in Social Work or Marriage and Family Therapy from an accredited college or university. We are looking for candidates who have a passion to help under-served ethnic populations and interested in gaining experience in the mental health field. The candidate must have knowledge using the DSM-V and able to adapt to change in fast-paced and supportive team focused work environment. Candidate must have a valid registration with BBS and have a valid California driver license and reliable transportation. The candidate **MUST** be **fluent in Cantonese, Mandarin**. All other candidates ok to apply. Knowledge of LAC-DMH and CalWORKs paperwork are highly preferred.
