### ***Psychiatric Social Workers – Associate Marriage Family Therapists Bilingual Spanish***

**APCTC** is a private, non-profit, community based mental health clinic with over 30 years of service to the Asian Pacific Islander community in Los Angeles County. Asian Pacific Counseling & Treatment Centers is a division of Special Service for Groups (SSG) and was the very first mental health center in LA County specifically developed to meet the unique needs of rapidly growing numbers of API immigrants and refugees who were in need of a wide range of mental health services. While our centers specialize in serving the monolingual Asian Pacific community, we provide services to the entire community and offer services in English and Spanish as well.

**APCTC** has an immediate, full time therapist position opening for a **fluent Spanish language** clinician at our **Cerritos location (11050 E. Artesia Blvd. suite F, Cerritos, CA 90703)**. The therapist will be working with various age groups ranging from children to adults who have moderate to persistent mental illness.

**Responsibilities:** Under the guidance of the Program Manager and clinical supervisor, the PSW I/AMFT has primary clinical responsibilities in providing individual, group and family counseling, intake assessment, crisis intervention, outreach and referral services at our clinic, school-sites, board and care facility, client's home or facilities where clients reside. Depending on program assignment, there will be close collaboration with relevant parties, such as school staffs, DCFS workers, Probation officers, Regional Center workers, family members, board and care facility, etc.

**Requirements:** The candidate must have a Master's Degree in Social Work or Marriage and Family Therapy from an accredited college or university. The candidate must have a strong interest and comfort level in working with all age groups and are familiar with DSM-V and ICD-10 and able to thrive in a fast-paced, team-focused environment. Candidate must have a valid registration with BBS and have a valid California driver license and reliable transportation. The candidate **MUST** be **proficient/fluent in Spanish**. All other candidates ok to apply. Knowledge of LAC-DMH paperwork is highly preferred.
